# **Research Program**

Abundant Intelligences is an ambitious, large-scale six-year research program exploring how to integrate Indigenous Knowledges and Artificial Intelligence systems. It is conducted by an international research team, co- directed by Prof. Lewis at the Indigenous Futures Research Centre at Concordia University, Montreal, and Prof. Hemi Whaanga at Massey University in New Zealand. The research team currently consists of 48 co-investigators and collaborators at 13 universities/research institutes and 8 community-based organizations in Canada, the United States, and New Zealand.

#### Job description

This position manages the day-to-day financial functions for all of the research programs in Lewis' lab. The incumbent will support the PI and the Abundant Intelligences (AbInt) Senior Program Manager with financial management of operational and project budgets, grants, and expense reports as well as processing contracts for professional and student research staff. The incumbent is the liaison between the PI's lab and Concordia Finance and Human Resources units.

# Responsibilities will include:

- Financial management of operational and project budgets, grants, expense reports, payroll, and contracts for professional and research staff;
- Preparation and analysis of periodic financial statements, budget reviews and reconciliation of project accounts;
- Reconcile & analyze internal and external funding transfers;
- Reviews & analyze expenses charged to project accounts to ensure that University policies and Funding Source requirements are respected;
- Supervise financial staff: assign work, provide direction, support and develop training;
- Oversee preparation of financial and HR transactions charged to project account;

- Investigate financial discrepancies or anomalies and communicate with relevant research team member;
- Act as liaison and a resource person for internal and external stakeholders for dossiers related to the financial activity of project accounts;
- Perform any other tasks related in support of the proper financial functioning of the project or as required by the supervisor.
